Reasons to Celebrate!!

The Tobacco Free Sarpy (TFS) Coalition has many reasons to celebrate this year. TFS played a part in helping businesses and landlords adopt tobacco-free policies. Our partnership with Sarpy County law enforcement agencies led to the completion of compliance checks of all retail tobacco license holders in an effort to keep tobacco products out of the hands of youths. The coalition has provided public education regarding the benefits of tobacco-free outdoor spaces at several community events. We also continue to provide resources on smoke-free and tobacco-free business campuses and multi-family housing. There are more than 25 Sarpy County businesses that have embraced a tobacco-free campus policy as well as 93 smoke-free multi-family housing buildings. Sarpy County tobacco license holders have a 97% compliance rate in keeping tobacco out of the hands of minors.

Tobacco Free Sarpy held its annual recognition luncheon at Bellevue University in March. Alex Brown, Prevention Specialist from LiveWise Coalition., served as Master of Ceremonies. Keynote speakers, Robin Larsen from SAC Federal Credit Union, Doug Huggins from Sumtur Amphitheatre and Margaret Stamp from Highland Meadows Apartments spoke on the importance of smoke-free and tobacco-free policies at their facilities.

"We come together once a year to share our history and show our accomplishments in the fight against tobacco. The celebration would not be possible without the commitment of our community partners and their efforts to reduce tobacco use." said TFS Coordinator McKinsey Mulroy. "We have made great strides in Sarpy County and as we continue to spread our message. Our luncheon highlights the community's success."

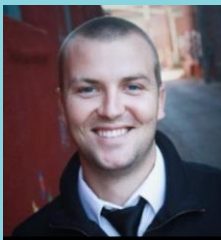

We are happy to report that there are 93 multi-family buildings in Sarpy County that offer smoke-free housing. TFS recognized Papillion Heights and Tuscany Apartments in April for their smoke-free policies. "TFS has had a large amount of requests for educational materials on smoke-free housing. The increase is due to recent apartment fires in the metro area from poorly discarded cigarettes" said Becky Smart, TFS Associate. "We supply landlords and managers with educational materials along with sample leases to help with the implementation of a smoke-free policy."

Did you know?

COMPLIANCE CHECK RESULTS

January - March 2014

Of the 95 tobacco retail businesses checked by the Bellevue Police Department, LaVista Police Department and the Sarpy County Sheriff's Office, three locations in Sarpy County sold tobacco to minors, resulting in a 97% compliance rate.



Vapor Products Now Illegal to Sell to Minors

On April 9th, 2014, Nebraska Governor Heineman approved legislation which brings several important changes impacting the sale and display of

cigarettes, cigars, vapor products (e-cigarettes and similar products), alternative nicotine products," or tobacco in any form. Nebraska Legislative Bill (LB) 863 which, among other provisions, added vapor products to the list of tobacco-based items that are illegal to sell to minors younger than 18.
